
**ORDER**

Upon review of the Amended Complaint (ECF 21), Motion to Proceed in Forma Pauperis (ECF 19), and Notice of Voluntary Dismissal (ECF 18) as to Plaintiff Anthony Blue, it is this 9<sup>TH</sup> day of September, 2016, by the United States District Court for the District of Maryland, hereby ORDERED that:

1. The complaint as to Anthony Blue IS DISMISSED without prejudice;
2. Plaintiffs' Motion to Proceed in Forma Pauperis (ECF 19) IS GRANTED;
3. The Clerk SHALL AMEND the docket to include Department of Public Safety and Correctional Services, Stephen Moyer, Dayena M. Corcoran, and Richard Miller as Defendants and CORRECTING the spelling of Plaintiffs' names;

The Clerk SHALL TRANSMIT a copy of this Order and the First Amended Complaint (ECF 20) to: Assistant Attorney General Stephanie Lane-Weber, Correctional Litigation Unit AND Mike Doyle, Deputy Counsel, Office of the Attorney General, Department of Public Safety and Correctional Services. If counsel is not willing to accept electronic service on behalf of Defendants, then counsel is requested to so notify this Court in writing after receipt of all documents. If counsel is willing to accept service, counsel shall promptly enter an appearance. If service is not accepted by these individuals the Clerk is to cause process to be promptly issued;
5. The Clerk SHALL OTHERWISE WITHHOLD service as to Defendants;
6. Defendants SHALL RESPOND to the Complaint in accordance with Rule 12(a) of the Federal Rules of Civil Procedure and *In re State Prisoner Litigation*, Misc. No. 00-308, Standing Order 2012-01 (D. Md 2012);
7. If Defendants require an additional period of time in which to respond, counsel SHALL FILE such a request for extension within sixty (60) days, pursuant to the aforementioned Federal Civil Rule 12(a) and Administrative Order 2012-01; and
8. The Clerk SHALL PROVIDE a copy of this Order to counsel for Plaintiffs.
