ORDER

In accordance with the Opinion issued this date;

IT IS HEREBY ORDERED that plaintiffs' motion for temporary restraining order and preliminary injunction is **GRANTED** until December 1, 1996;

IT IS FURTHER ORDERED that defendants shall continue to fund Prison Legal Services of Michigan, Inc. until December 1, 1996, subject to extension by this Court, unless before that time they submit to the Court, and the Court approves, an alternative interim plan;


IT IS FURTHER ORDERED that the funding provided to PLSM by defendants shall be used to assist inmates only in cases involving challenges to their sentences or convictions, or involving the conditions of their confinement;

IT IS FURTHER ORDERED that the defendants' Final Plans for the Legal Writer Program in Hadix v. Johnson, dated May 30, 1996 and filed June 19, 1996 (dkt. #727) is **ADOPTED** with the modifications set forth in the accompanying Opinion;

IT IS FURTHER ORDERED that the defendants' Final Plans for the Legal Writer Program in Knop v. Johnson, dated May 30, 1996 and filed June 20, 1996 (dkt. #1242) is **ADOPTED** with the modifications set forth in the accompanying Opinion.
