PROPOSED PLAN AND PHASE-IN TIMETABLE

COME NOW, the Defendants in the above styled and numbered civil action, by and through counsel and submits this their proposed plan and phase-in timetable for implementation of the Agreed Judgment of Settlement and Dismissal in this cause which was entered on June 28, 1995 herein:

I

Housing Plan and Timetable

The implementation of the housing plan will be as new HIV inmates enter the system. They will be assigned to Unit-28 unless some restrictive housing is needed. When there are enough HIV inmates to fill Unit-28, the unit will be designated as the HIV unit. An alternative plan to use another smaller unit will be explored.

II

Jobs, Exercise and Sports Plan and Timetable

Unit-28 support jobs will be available to HIV inmates: yard crew; kitchen workers; clerks; canteen operator;

pants/laundry man; janitors; and short line. Phase-in will begin when the elderly, disabled inmates are moved from the unit.

Each yard call period will be increased by fifteen (15) minutes (morning, afternoon and evening), if there are no conflicts. Checkers, chess, dominoes and unit games may be available. Weights, volleyball equipment, basketball equipment, horse shoes and softball equipment may be issued.

Basketball, volleyball, weight lifting and ping pong may be available.

In the Spring, Summer and Fall, as weather permits, class members may have a softball league one afternoon a week. They may also spectate at other inmate games, concerts and other activities if security can be maintained.

### III

#### **Educational Activities/Courses Plan and Timetable**

The equipment for the Unit-28 Learn, Earn, and Prosper (LEAP) program has arrived. The equipment is being installed as of this date. The first classes are scheduled to begin by October 1, 1995. This program has been contracted through the University of Mississippi.

### IV

#### **Extended Family Visitation Plan, Policy and Rules**

Attached to this proposal and fully incorporated herein is the extended family visitation plan, policy and rules.

V

**Use of Gym**

The class member inmates from Unit-28 will be permitted to begin using the gym at Unit-30 within thirty (30) days of this date. They may have use of the gym once a week unless there are security reasons to cancel use of the gym that week.

VI

**Medical Diet Plan**

The attached policy has been implemented.

VII

**Sick Call Plan**

The attached sick call plan has been implemented.

VIII

The Defendants will strive to provide services consistent with the proposed plan, but shortage of staff, security demands, weather, changes in state statute, etc., may influence the extent and method of services provided.

**AND NOW,** having fully reported to the Court its proposed Plan and Phase-in Timetable, the Defendants would

request that the Court enter an order approving said plan and timetable and for such other relief as may be deemed appropriate.
