WHEREFORE, plaintiff prays a Temporary Restraining Order issue, followed by a preliminary injunction.



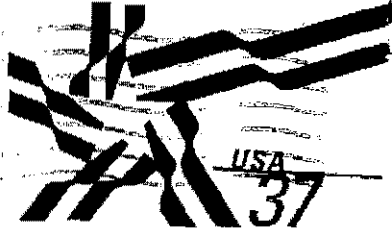
