

ORDER APPROVING  
STIPULATION OF  
SETTLEMENT AND ENTRY  
AS CONSENT JUDGMENT

WHEREAS the parties have entered into a Stipulation of Settlement, which is attached hereto, settling this class action lawsuit addressing the use of force policy at Brooklyn House of Detention ("BHD"), use of force training for correctional staff at BHD, training of investigators assigned to review incidents in which force was applied to inmates at BHD, monitoring and reporting of use of force incidents at BHD, the investigation of incidents in which force was applied at BHD, the administrative prosecution of officers who violate Department of Correction policy concerning use of force at BHD and the placement and retention of officers at BHD who are involved in use of force incidents; and

WHEREAS the parties have agreed to the entry of a Judgment by consent incorporating the terms of the Stipulation, subject to the Court's approval after notice to the plaintiff class; and the Court having entered on October 25, 1991 an Order providing notice to the class; and notice to the plaintiff class having

been provided as set forth in the October 25 Order; and the Court having conducted a hearing on November 26, 1991 concerning the proposed settlement in which the Court considered the comments of members of the plaintiff class; and the Court having found that the terms of the proposed settlement are fair and reasonable and adequately protect the legal rights of all members of the plaintiff class;




