WHEREAS the parties have entered into a Stipulation, which is attached hereto, settling this class action lawsuit concerning the provision of psychiatric care and conditions of confinement at the Bellevue and Elmhurst Hospital prison psychiatric wards; conditions of confinement at the Kings County Hospital prison psychiatric ward; fire safety on the prison medical and psychiatric wards at all three hospitals; and the shackling of outposted prisoners and services to be provided to them at Bellevue, Elmhurst and Kings County Hospitals, and they have agreed to the entry of a judgment by consent incorporating the terms of the Stipulation, subject to the Court's approval after notice to the plaintiff class; and the Court having entered on August 14, 1990, an Order providing notice to the plaintiff class of the proposed settlement; and notice to the class having been provided as set forth in the August 14, 1990 order; and the Court having conducted a hearing on September 27, 1990 concerning the proposed settlement in which the Court considered the comments of members of the plaintiff class with respect to the settlement; and the Court having found that the terms of the proposed settlement are fair and reasonable and adequately protect the legal rights of all members of the plaintiff class;

ADJUDGED and DECREED

IT IS HEREBY ORDERED that the Stipulation, attached hereto,  
is approved and adopted as a Judgment of this Court.


