Upon the above reference. I am currently assigned on the William G. McConnell prison unit. As of 05/16/12 my recently filed case with the USDC was unjustly seized by the administration (every known document and piece of evidence pertaining to the case).

I am being retaliated and harrassed against bt the administrator and her hench men(Warden Davis, Major Castro, SGT. Mayor). Their attempt to unjustly impede this suit was not provoked by me or said co/ plaintiff Robbie Goodman # 758386.

Clearly the McConnell unit administration is not only attempting but succeeding in with holding the necessary legal documentation and papers so thefurther necessary filing attachments cannot be pursued.

I am humbly coming before the USDC Judge to impose any temporary injunction to cease and de cease, and a temporary restraining order from the retaliation and harassment, and the withhold of or impediment of allowing me access to my document file paperwork and exhibit evidence. Please in consideration duly review with urgency.

#1). On 05/15/12 I filed my lawsuit against TDCJ Officials on this unit. (see above RE).

#2). On 05/16/12 Arrested as well as the joinder /Co-plaintiff Robbie Goodman. All legal materials, envelopes, writing materials, carbon paper and such were taken from us. We cant even write our family and loved ones at this point and time. I am having to borrow this typing paper and envelope and stamp just to mail this letter to you.

#3). I was sent to the building one(1BLDG) administration at 11:00 am and sat there until 6:00pm without anything to eat for lunch nor supper nor water to drink. Then I got moved to the building and got a job change from dorm housing and inside yard (landscape/ Gardener). I was placed on the building in which I am dorm eligable. I got no case but was retaliated against. I'm on three(3) building (A) pod (2) section and I have been put into the laundry as a folder. I have been living in the dorms for the past four to five years until I filed this lawsuit. TDCJ officials immediately started retaliating against me. I have wrote up a step one grievance against TDCJ officials for their retaliation but I have not sub - mitted it to the grievance office yet because they will retaliate against me further. I wanted to notify the courts of such activities going on with me hoping that the courts will help me with my delima before it gets worse. I am sending you a copy of the step one I am submitting to them. I would like to ask the said court judge to have TDCJ put me back into the dorm housing and give me my same job back. There is no reason to be shipped off this unit because this is my assigned Native American unit. Thank you for your time in this matter.

On 05/16/12 at 8:00am the entire inside yard crew was arrested and taken to 8 BLDG for questioning behind another inmate. They the TDCJ officers in (1) BLDG. administration Warden Davis, Major Castro, SGT Mayor had everyone who works in the inside yards property taken away behind something another inmate has done.
I have just recently filed a lawsuit against TDCJ - ID officials on this unit on (05/15/12) and today 05/16/12 all my belongings were taken away that were legal. I have no writing paper, envelopes, nor addresses or legal work. The upper administration has taken it all away from me. The administration has over \$450.00 worth of certified legal documents from the USDC in Corpus Christi that are evidence in my law suit now. They consist of documents such as O'neal vs. Pierce, and Yellowquill vs. TDCJ et al, . At this point and time I feel that for whatever reason you state you have my belongings is retaliation against me for filing the lawsuit against TDCJ. At this point and time you are hindering me access to the courts by having all my legal work and legal materials. I would like to have all my legal materials returned immediately please undamaged and in order as was sent to me from the USDC. S.M. 03.02 (rev.1) reference: American Correctional Association "searches shall be conducted in an orderly and professional manner, being careful not to unduly disorganize, scatter, or destroy property. Policy standard 3 - 3184. My legal materials have nothing to do with your investigation on another inmate nor another officer. I request that you return my legal work back to me immediately. I am notifying the USDC Judge and ask for an emergency restraining order and temporary injunction be placed on the unit staff of this unit to were our line class, custody level, job, housing, and such cannot be taken from us in the course of this lawsuit and that you and your staff cannot take our legal materials from us nor our legal copies of our lawsuits and etc... from us. I'm sure that the USDC Judge will find it interesting to know what legitimate reason you have for taking our legal materials away from us. Like I have said before Inmate Bill Cockran and officer rossenburge if this is spelled right have nothing to do with my legal belongings. I feel that you are making copies of my legal documents on the cool. I will let you all explain to the USDC Judge when he/she notifies you all on this unit. Just because I don't know anything to tell you about these two people, Inmate cockran and officer rossenburge doesn't give you the right to take my legal work and when you asked me if I was

A native American and if I was the one who filed the lawsuit still does not give you the right to take my belongings and retaliate against me and make threats to me saying If I don't tell you what You want to hear you will take care of me. That you have up to this point and time. anything else you want to do to me like my line class, med. custody, segregation ?

**Action Requested to resolve your Complaint.**

That you stop retaliating against me and give me all my property back and give me my job and dorm housing back.

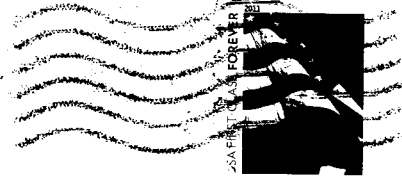

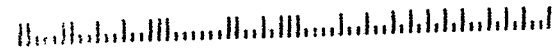
