STIPULATION

The parties to the above-captioned class action hereby stipulate to the following modifications of the Settlement Agreement signed on October 12, 1994:

1. Section II. ¶¶ 21-32 at pages 7 - 10 require the Bureau of Corrections to develop policies, procedures and documentation regarding nutritionally adequate and sanitary food service delivery. The implementation date for each of these provisions is December 7, 1994.


2. Section II. ¶¶ 36-37 at pages 10 - 11 of the Agreement require the Bureau of Corrections to provide prisoners with specific linens and hygiene supplies upon their admission to CJC. December 7, 1994 shall be the implementation date for the provision of hygiene items in ¶ 37 and for sheets, towels, pillow and blankets in ¶ 36. Inasmuch as the population reduction will not take full effect until April 1, 1995, the portion of ¶ 36

requiring that mattresses be placed off the floors shall be in effect as of April 1, 1995. As modified, ¶ 36 reads as follows:


Effective December 7, 1994, each inmate shall be given at a minimum the following linens: two sheets, one towel, one pillow, one blanket and a mattress. As of April 1, 1995, mattresses shall be placed on a bed and not on the floor. There shall be procedures for linen and towel exchange and personal laundry on a weekly basis, at a minimum, as of December 7, 1994.

3. Paragraph 38 at page 11 requires a written plan and regularly scheduled extermination services to combat roach and rat infestation on a monthly basis, at minimum. The implementation date for this provision is December 7, 1994.

The parties hereby adopt the modifications specified in paragraphs 1 - 3 above.
