The Court overrules the City's objection. The essence of the Complaint challenges an alleged practice by the police department to take civilians to Homan Square, instead of to one of the numerous police stations, "to hold arrestees 'incommunicado' or 'off the grid,' without processing the arrestee or making any public record of the arrest for long periods of time." (Dkt. 132 at 11). In light of the allegations of secrecy contained throughout the Amended Complaint, limiting Plaintiff's inspection to "the middle of the second floor" strikes the Court as completely inconsistent with the purpose of discovery allowed by the Federal Rules of Civil Procedure. Plaintiff will be permitted to inspect all five floors of the building. However, the Court is committed to protecting the identities of undercover officers and operations. Therefore, any portion of the inspection outside of the "middle of the second floor" shall be done without the Plaintiff's photographer. Furthermore, no photographs or videoing will be permitted. The inspection, which is limited to two hours, is to take place by 1/22/16. If the identity of any police personnel is captured on photo or video, it shall be redacted. All photographs and video will be produced by Plaintiff for the City's counsel to review for attorneys' eyes only. Plaintiff is permitted to bring a total of 7 people to the inspection. No actual plaintiffs may attend only counsel, a photographer, and an investigator who is permitted to bring equipment to test for blood and human excrement throughout the building. Any agreed protective orders shall be submitted to Proposed_Order_Rowland@ilnd.uscourts.gov.
