1. All procedures set forth in the Court's December 14, 2009 Order Certifying Settlement Class, And Approving Settlement, Attorneys' Fees and Costs, Plan of Allocation, And Appointment of Class Representative have been complied with and the settlement has been conducted in an appropriate manner for all involved.
2. The letter submitted by class counsel from class member Jesse Nyboer is not an appeal properly before the Court as it was not timely submitted to the Court as required under the Plan of Allocation.
3. The individual awards as set forth in the attached Exhibit 6 to Class Counsel's Report for Final Fairness Hearing Scheduled for February 16, 2010 are approved and class counsel is authorized to distribute the funds to the individual class members.
4. This matter is dismissed with prejudice.

5. The Court retains jurisdiction to enforce the Settlement Agreement dated October 30, 2009 and the Terms of Equitable Relief dated October 21, 2009.
