Comments: We grant the request to exercise our King's Bench jurisdiction. For the reasons set forth in this opinion, we conclude that Respondents had the statutory authority to issue the Executive Order and that Petitioners have not established any basis for relief based upon their constitutional challenges. The claim for relief requested in the Application, to vacate or strike the Executive Order, is therefore denied. Justices Baer, Todd and Wecht join the opinion. Chief Justice Saylor files a concurring and dissenting opinion in which Justices Dougherty and Mundy join.
