Finally, the School District shall distribute a copy of the Notice to each student in the school system who is in attendance on a regualr school day between March 7 and March 11, withi instructions to the students to deliver the copy to their parents or legal guardian. The Court will conduct a Fairness Hearing for the purpose of considering any comments upon or objections to the proposed settlement by members of the plaintiff class, if there are any such objections, comments or requests to appear at a hearing that have been timely filed with the Court. The hearing shall be held in the United States Courthouse, 800 Lafayette Street, Courtroom #3, Lafayette, Louisiana at 10:00 a.m. on March 24, 2011.granting 277 Motion to conduct fairness hearing and preliminarily approve settlement.
