The Plaintiff–Intervenor U S A filed a response, stating it does not oppose the motion. After a review of the motion and the memorandum and exhibits in support thereof, the Court finds that the School Board has fulfilled the requirements in Green v. County School Board of New Kent County, Virginia, et al. The School Board, having acted in accordance with the orders of this Court and in compliance with applicable legal principles, has eliminated the vestiges of past discrimination; further supervision by this Court is no longer warranted. Therefore, IT IS ORDERED, ADJUDGED, AND DECREED the <u>25</u> Motion for Declaration of Unitary Status and to Dismiss be and is hereby GRANTED. IT IS FURTHER ORDERED, ADJUDGED, AND DECREED all previous injunctions and orders granted by this Court are hereby VACATED AND LIFTED.
