

LIMITED DISCOVERY RELATED TO FEES AND COSTS

On October 14, 1997, Plaintiffs filed this class-action lawsuit challenging the admissions policy of the University of Michigan's College of Literature, Science, and the

Arts. Presently before the Court is Plaintiffs' motion for an award of attorneys' fees and costs pursuant to 42 U.S.C. § 1988. For the reasons set forth in an Opinion issued on this date,

IT IS ORDERED, that Plaintiffs' Motion for an Award of Attorneys' Fees and Costs Pursuant to 42 U.S.C. § 1988 is GRANTED IN PART AND DENIED IN PART;

IT IS FURTHER ORDERED, that Defendants shall pay Plaintiffs the Maslon law firm's attorneys' fees in the amount of \$346,704.84 and costs in the amount of \$3,947.75;

IT IS FURTHER ORDERED, that Defendants shall pay Plaintiffs the attorneys' fees of CIR (which includes fees for Patrick Wright) in the amount of \$76,418.78 and costs in the amount of \$239,681.30;

IT IS FURTHER ORDERED, that Defendants shall pay Plaintiff Kerry

Morgan's attorney's fees in the amount of \$5,170 and costs in the amount of \$75.08;

IT IS FURTHER ORDERED, that Plaintiffs' Motion to Allow Limited
Discovery Related to Fees and Costs is DENIED.
