



ORDER

Pursuant to the Mandate in the above action of the United States Court of Appeals for the Fifth Circuit received by the Clerk of this court, it is

ORDERED, ADJUDGED AND DECREED:

1) That on December 1, 1971 and April 15, 1972, and on the same date annually thereafter, until further orders of this court, defendant School Board shall file with the clerk of this court a report setting forth the following information:

I.

a) The number of students by race enrolled in the school district;

b) The number of students by race enrolled in each school of the district;

c) The number of students by race enrolled in each classroom in each of the schools in the district.

II.

a) The number of full time teachers by race in the district;

b) The number of full time teachers by race in each school in the district;

c) The number of part time teachers by race in the district;

d) The number of part time teachers by race in each school in the district.

III.

Describe the requests and the results which have accrued, by race, under the majority-to-the minority transfer provision which was a part of this court's order of August 5, 1969, as amended by Order of January 12, 1970.

IV.

State the number of inter-district transfers granted since this court's order of April 7, 1970, the race of the students who were granted such transfers, and the school district to which the transfers were allowed.

V.

State whether the transportation system, if any, in the district is desegregated to the extent that Negro and white students are transported daily on the same buses.

VI.

State whether all facilities such as gymnasiums, auditoriums, and cafeterias are being operated on a desegregated basis.

4) That a copy of this order shall be sent to all counsel of record as notice of the entry thereof.

CONSENT ORDER

THIS CAUSE having come on this day upon the motion of the Hollandale Consolidated School District to modify this Court's order of August 4, 1970 so as to allow the School District to sell and dispose of the Hollandale Attendance Center, and this Court, by its order of August 4, 1970, has provided that said facility could not be disposed of by the Hollandale Consolidated School District without prior approval of this Court, and the parties being present by and through their attorneys, and having announced to the Court that the Plaintiffs have no objections to said sale upon the following terms and conditions and that the Hollandale Consolidated School District having agreed to said conditions: that upon the sale of said real property that the deed conveying said property contain in it a reversionary clause that the property shall revert to the Hollandale Consolidated School District if within the period of ten (10) years from the date of said sale said property is used for private school purposes.

IT IS, THEREFORE ORDERED AND ADJUDGED that this Court's order of August 4, 1970 is and shall be modified to provide that the Hollandale Consolidated School District may dispose of the Hollandale Attendance Center upon the terms and conditions that the deed conveying said real property contain in it a provision that in the event said property is used for private school purposes within ten (10) years from date of said conveyance,

then the property shall revert back to the Hollandale Consolidated School District.
