Pursuant to the Findings of Fact and Conclusions  
of Law entered on this date:

1. It is ADJUDGED that John Allen Blackburn,  
Mrs. W. F. Barnette and Dudley Pearson are guilty of  
civil contempt of this Court for violating the Orders  
of this Court of November 15, 1962 and May 17, 1963.

2. It is further ORDERED and ADJUDGED that John  
Allen Blackburn, Mrs. W. F. Barnette and Dudley Pearson  
perform and continue to perform the following:

- a. Place upon the current voter registration  
rolls of Perry County, Alabama, and do  
all other acts necessary to complete the  
registration for voting in Perry County  
of the Negro citizens listed in the at-  
tached Appendix who applied for and were

illegally denied registration to vote in Perry County, Alabama, including sending to such Negro citizens by United States mail, postage prepaid, registration certificates ordinarily used in Perry County identifying such citizens as registered voters in Perry County.

- b. Register every Negro applicant in the future who meets the following substantive qualifications:
- (1) He is a citizen of not less than twenty-one years of age,
  - (2) He has resided in the state one year, in the county six months, and in the precinct three months,
  - (3) He embraces the duties and obligations of citizenship as demonstrated by his willingness to take and to subscribe the loyalty oath prescribed by Alabama law,
  - (4) He is not disqualified by reason of bad character, conviction of a disqualifying crime, insanity or idiocy, habituation to drink or dope addiction.
- c. Make no changes, beyond those herein ordered, in the procedures or requirements for voter registration in Perry County, unless such changes have been first filed with and approved by this Court.
- d. Cease rejecting qualified Negroes on the ground that they did not sign the loyalty oath, unless they refused to sign the oath.

- e. Cease rejecting Negro applicants for errors or omissions in their applications. It is the duty of the defendants to determine from the applicant whether he meets the qualifications set forth in subparagraph b above and to obtain from the applicant any information necessary to make that determination.
- f. Cease requiring Negro applicants to obtain or produce a supporting witness, and cease rejecting Negro applicants for their failure to supply a supporting witness.
- g. Cease requiring Negro applicants to demonstrate their ability to read, write, understand or interpret any subject whatever, in the absence of a complete re-registration of all voters in Perry County.
- h. Expedite the registration of voters in Perry County by adopting procedures to accommodate simultaneous registration of at least twelve applicants, to insure that applicants are allowed to make application in the order in which they appear for such purpose, to process all applications within ten days, and otherwise to register all qualified Negro citizens in Perry County desirous of becoming registered to vote. The defendants shall file with the Clerk of this Court within two weeks of the date of this Judgment and Order a report showing the procedures which have been adopted in compliance with this subparagraph.

- i. Notify each rejected applicant by pointing out to him before he leaves the registration office the specific reason for his rejection.
- j. Permit the Attorney General of the United States through his authorized representatives to inspect, copy, and photograph any or all voter registration records of Perry County at any and all reasonable times during regular office hours.

3. It is further ORDERED and ADJUDGED that John Allen Blackburn, Mrs. W. F. Barnette and Dudley Pearson, in order to purge themselves of civil contempt of this Court, shall within ten days of the date of this Judgment and Order perform and comply with Paragraph 2a of this Judgment and Order, failing which said persons shall be remanded to the custody of the Attorney General of the United States for imprisonment until compliance and performance is effected.

4. It is further ORDERED and ADJUDGED that the costs and expenses of the United States for the preparation and prosecution of this proceeding be, and they are hereby, taxed against the defendants John Allen Blackburn, Mrs. W. F. Barnette and Dudley Pearson.

Except to the extent modified by this Judgment and Order all previous Orders in this case remain in full force and effect.
